To Whom It May Concern:

This firm represents Mercury Radio Arts, Inc. and Glenn Beck.

It has come to our attention that your company registered the highly defamatory domain name glennbeckrapedandmurderedayounggirlin1990.com (the "Defamatory Domain") on behalf of an unknown individual, and that your company is providing privacy protection services for that unknown individual.

Registration of the Defamatory Domain and your continued provision of privacy protection services to the unknown individual clearly violates a number of provisions of the WhoisGuard Service Agreement and NameCheap.com's Registration Agreement. Specifically, the Defamatory Domain, which on its face improperly asserts that Mr. Beck engaged in criminal activities, is plainly libelous and a violation of Mr. Beck's legal rights. Moreover, it is plain that the unknown individual is using NameCheap.com's WhoisGuard services to engage in illegal and/or morally objectionable activities as the Defamatory Domain was registered to defame, embarrass and harass Mr. Beck – which violates the Registration Agreement's mandate not to use NameCheap.com's services for improper purposes.

Consequently, we demand that by the close of business today, you suspend and/or terminate your provision of WhoisGuard privacy protection services to the unknown individual, provide us with contact information (including but not limited to his name, address, phone number and e-mail address), and delete the Defamatory Domain.

Nothing herein shall be construed as a waiver of any rights and/or claims currently held or that may be held in the future by our clients, all of which are expressly reserved.
